#### **Scholarship Details & Eligibility Requirements:**

- **1.** To be eligible for this one-year scholarship (with the potential to apply for a second year), the applicant must be a resident of Greene County, recently graduated, or a 2024 graduate who has committed to, or who has an interest in law enforcement.
- **2.** Even though it is not a requirement in consideration of this scholarship, applicants are encouraged to be a registered voter, if eligible.
- **3.** The scholarship may be used at any accredited educational institution of the applicant's choosing.
- **4.** The scholarship will be in the amount of \$2,000 for the 2024 -2025 school year and may be used for tuition only. The scholarship will be paid directly to the recipient's educational institution of choice.
- **5.** A successful scholarship recipient must continue to meet all eligibility requirements and re-apply to be considered to receive a second-year award.
- **6.** The Scholarship Committee reserves the right to interview applicants if deemed necessary. If so, you will be notified by a phone call, email, or text.
- **7.** All decisions and rulings by the Scholarship Committee are final.
